Her research lies at the crossroads of disciplines and geographies: transnational sovereignties, mediation, hierarchy in postcolonial settings. She has recently completed an ethnographic census of the Muslim population in Mexico and is working on a research project on performance and prostitution in the Mandate Mediterranean.
