

# GLOBAL HEALTH MINOR

*The minor in Global Health — through a broad inventory of courses that provide a solid foundation in, and familiarity with, social determinants of health, epidemiology, environmental health, nutrition, data collection, and evaluation methods — allows students to develop an interdisciplinary understanding of health issues in a global context.*

*Students undertaking the Global Health Minor explore the institutional, economic, logistic, legal, social and artistic challenges facing global health solutions, investigate the health implications of globalization, as well as address issues of social justice and development, which are crucial to understanding the determinants of health issues around the world.*

### **Admission to the Minor:**

- ❖ A minimum of 20 units applied toward the minor requirements must be in addition to units applied toward major requirements or another minor.
- ❖ Students must request that the Global Health Minor be added to their records once all preparation requirements have been completed. Successful completion of the minor is indicated on the transcript and diploma.
